Record of Discussion of the 19th Meeting of the Approval Committee to consider the proposals of Greater Visakhapatnam Smart City Corporation Limited (GVSCCL), Government of Andhra Pradesh for hiring Transaction Advisors under HPDF Scheme.

The 19<sup>th</sup> Approval Committee (AC) Meeting chaired by the Joint Secretary, ISD Division, Department of Economic Affairs (DEA) was held on 7<sup>th</sup> March 2024 at 1530 hours to consider the proposals submitted by GVSCCL. Government of Andhra Pradesh under the IIPDF Scheme. List of participants (attendees) is placed at Annexure – 1.

2. On behalf of the Chair, Joint Director (PIU) welcomed the attendees to the 19<sup>th</sup> Meeting of the Approval Committee and informed that two project proposals were received from Greater Visakhapatnam Smart City Corporation Limited (GVSCCL), Government of Andhra Pradesh, for water sector. Further, Joint Director (PIU) informed that the proposal has been duly circulated to all members of the Appraisal Committee (AC) and with the permission of the Chair, GVSCCL was invited to make a presentation on the proposal.

# Development of Non-Revenue Water (NRW) monitoring and management in water supply system in Visakhapatnam.

3. The proposal was for monitoring Non-revenue water and management of water supply system in Visakhapatnam. GVSCCL jointly with GVMC has identified the timely need to enhance the efficiency of the water supply systems by reducing NRW, and intends on attracting private sector participation through a structured transaction process to deploy a system for continuous monitoring and systemic reduction of NRW. A brief overview of the project is provided below:

4. After detailed deliberations, it was observed that the PSA has no clarity on the project and private partners role in the project. The Approval Committee decided to defer consideration of the

project proposals for funding of TA costs under IIPDF Scheme and requested the PSA to come up with clear project contours and scopes on PPP mode.

- II. Enhance energy efficiency of water supply and wastewater systems for Greater Visakhapatnam Municipal Corporation (GVMC).
- 5. The proposal was about enhancing energy efficiency of water supply and wastewater systems for GVMC. Water supply systems consume significant amounts of energy to pump water from various sources to the treatment plant, reservoir, across the distribution network and to the end users. GVMC spends a considerable portion of its budget towards energy costs.
- To develop the project, GVSCCL submitted the proposal under IIPDF scheme to hire transaction advisers. The basic details of the project are outlined below.
